During 2023-2024, we helped young Indonesians to participate in civic issues and government officials to hear young voices via community-developed, local language digital platforms. Thousands of young people from two Indonesian provinces regularly participated in our public participation wikithons, either by submitting entries or by responding to entries submitted by others. Policymakers from multiple government agencies sat on wikithon juries and publicly responded to young people's suggestions. Six wikithons were held in each of two provinces for a total of 12 wikithons. Cumulatively, more than 4 million have used the wikis to date.
